ORDER MODIFYING ORDER  
 GOVERNING DISCLOSURE AND USE OF DISCOVERY  
 INFORMATION AND SCHEDULING DATES


Pursuant to the Stipulation for Order Modifying Order Governing Disclosure and Use of Discovery Information and Scheduling Dates (the “Stipulation”) entered into by the California Public Employees’ Retirement System (“CalPERS”), the City of Stockton (the “City”), and Franklin High Yield Tax-Free Income Fund and Franklin California High Yield Municipal Fund (“Franklin” and collectively with CalPERS and the City, the “Parties”), and good cause appearing therefore,

IT IS HEREBY ORDERED that:

The Court’s January 30, 2014, Order Modifying Order Governing the Disclosure and Use of Discovery Information and Scheduling Dates Related to the Trial in the Adversary Proceeding and any Evidentiary Hearing Regarding Confirmation of Proposed Plan of Adjustment [Docket No. 1242], which amends the Court’s December 10, 2013, Order Governing the Disclosure and Use of Discovery Information and Scheduling Dates Related to the Trial in the Adversary Proceeding and any Evidentiary Hearing Regarding Confirmation of Proposed Plan of Adjustment [Docket No. 1224] (the “Scheduling Order”) is modified as follows:<sup>1</sup>

1. CalPERS’ deadline to file and serve a Direct Testimony Declaration of David R. Lamoureux setting forth testimony pursuant to ¶ 35(a) of the Scheduling Order (the “CalPERS Direct Testimony Declaration”) shall be April 23, 2014.
2. The deadline for any Party to serve a written objection to the admission of all or any part of the CalPERS Direct Testimony Declaration shall be April 29, 2014.
