For the reasons stated in the Opinion issued this date, it is determined that the automatic stays of 11 U.S.C. §§ 362(a) and 922(a) do not affect the ability of the movant to file and prosecute litigation challenging the accuracy of a ballot description of a tax proposed to the electorate by the City of Stockton on the condition that no effort be made in the litigation to obtain any form of monetary award (including fees or costs) against the City of Stockton.
