Notice is hereby given that a public hearing to consider the following actions:

1. City of Stockton's amendment to the 2023-2024 Annual Action Plan (AAP)
2. City of Stockton's amendment to the 2020-2021 Annual Action Plan (AAP)

The public hearing will be held on October 17, 2023 at 5:30 p.m. in the Stockton City Council Chambers (425 N. El Dorado Street, Stockton CA 95202).

The Annual Action Plan Amendments will also be presented to the City of Stockton Community Development Committee on September 13, 2023 at 3:30 pm, located in the Stewart Hazelton Room of the Cesar Chavez Library (605 N El Dorado St, Stockton, CA 95202).

The Annual Action Plans describe the goals and activities to be completed in the program year as it related to the use of Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant (ESG) funding from the U.S. Department of Housing and Urban Development (HUD).

The purpose of the 2023-2024 Annual Action Plan Substantial Amendment is to re-allocate CDBG funds to new or existing eligible activities to assist in meeting 2023-2024 CDBG timeliness expenditure thresholds.

The purpose of the 2020-2021 Annual Action Plan Third Substantial Amendment is to re-allocate CARES Act funds to assist in meeting program expenditure deadlines.

Proceeding this meeting, a 30-day public comment period will open from September 17 to October 17, 2023.
